The goal of this course is to teach thermodynamics of material systems (3 credits).

This is a graduate level course on materials thermodynamics. This course deals with the following areas: the laws of thermodynamics, thermodynamic variables and the relationships between those variables, equilibrium, statistical thermodynamics, phase diagrams, solution models, reactions with gases and capillarity. The use of thermodynamics for practical scientific and technical applications will be emphasized in the course.
