Materials selection and use of familiar materials, including metals, ceramics, polymers, electronic materials, and composites in electronics, structural and other engineering applications. (3 Credit Hours)

5. Course Objectives

This is an introductory course, designed to provide the fundamental concepts of Materials Science and Engineering. Students will be able to describe structure, properties, and applications of metallic, ceramic, polymeric and composite materials and how to select materials for a given application.

10. Course Website

This course will use CANVAS extensively as a communication and archival tool. The students can access all relevant course information (course notes, homework, problem sets, solutions, announcements, grades, etc.) via the CANVAS

entry link: https://ufl.instructure.com. Within CANVAS the students can purchase and access the book as well as Perusall and Wiley Plus. Please check CANVAS frequently.

11. Course Format

This course uses a <u>team-based learning approach</u> that uses pre-class preparation materials (including reading assignments and watching pre-recorded lectures on Perusall as indicated in the course schedule) and active learning activities during class time. Your completion and involvement in all these aspects of the course is critical to success.

12. Pre-Class Preparation Materials

- a) Reading assignments will be your first exposure to the course topics, will engage you in social learning, and will be a key pre-class activity helping you prepare for both the pre-recorded lectures and the in-class active learning activities. Your completion of the reading and interaction will be worth 10% of the course grade and will be assessed using Perusall.
- b) <u>Pre-Recorded Lectures</u> will help you prepare for the active learning activities and are a critical aspect of learning the content of this course. You are required to watch them using Perusall. Whether you watch and interact with the lectures will be evaluated and will be worth 10% of the grade.

Beyond their grade value, your completion and involvement in this component is critical to success. Details on Perusall platform use, social learning interaction and assessment will be covered in the first class session.

13. Active Learning Activities

- a) Social Learning in Perusall will allow you to interact with your classmates and the TA by collaboratively annotating the textbook and pre-recorded lectures. You can start a new annotation thread in Perusall by highlighting text, asking a question, or posting a comment; you can also add a reply or comment to an existing thread. Each thread is like a chat with one or more members of your class, and it happens in real time. Your goals in annotating each reading assignment are to stimulate discussion by posting good questions or comments and to help others by answering their questions. Through your Perusall interaction, you also advise the Instructor how to make class time most productive during the Q&A sessions.
- b) <u>Attendance to Live Classes</u> is technically not required but highly encouraged since there will be discussion as well as individual and group work on exercises. Students are encouraged to ask questions and participate. The fundamental concepts will be repeated as required.
- c) <u>Group Exercises (GE)</u> will be given during the live classes. These exercises will be performed in groups during class time and counted for credit. In total, GEs will be worth 25% of the grade. As such, attendance is essential to receive credit for this component.

14. Homework Problems

Homework is voluntary and will not be graded. However, suggested homework problems will be provided via Wiley Plus to help students prepare for the exams.

15. Exams

- a) There will be 5 exams presented in class throughout the semester. Your lowest exam grade will be dropped. Each exam is weighted equally, and each exam will be worth 10% of your final grade. You will have 30 minutes to complete each exam. Exams will be presented on CANVAS using Respondus LockDown Browser and Zoom.
- b) There will be a comprehensive final exam during finals week that is worth 15% of the grade.
- c) You have one week after the test results are posted to resolve any questions about scores and grades. No changes to your exam grade will be made after that time.
- d) **Exam Conflicts with other course exams**. The official UF policy on exam conflict resolution states that when two exams conflict, the course with the higher number will take priority. There will be no exceptions to this rule.
- e) <u>Make-up exams</u>. Students who do not take an exam will receive a grade of 0. Excused absences require appropriate documentation to warrant a make-up exam and must be consistent with university policies in the undergraduate catalog (https://catalog.ufl.edu/ugrad/current/regulations/info/attendance.aspx).

16. Syllabus Changes

The instructor reserves the right to make changes to the syllabus as needed. Any changes will be clearly announced on CANVAS and in class.

17. In-Class Expectations and General Make-Up Policy

a) Online Teaching. Although rarely, our class sessions may be audio visually recorded. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. Likewise, students who un-mute during class and participate orally are agreeing to have their voices recorded. If you are not willing to consent to have your voice recorded during class, you will need to keep your mute button activated and communicate exclusively using the "chat" feature, which allows students to type questions and comments live. The chat will not be recorded or shared. As in all courses, unauthorized recording and unauthorized sharing of recorded materials is prohibited. 18. Course Communication

E-Learning will be the primary avenue for communication and course management. All announcements for the course will be made using the announcement system on the E-Learning site. Close your e-mails by typing your name. Check your e-mail for grammar and spelling. Be concise. All of these guidelines are to promote professionalism.
