III. Course Description

(3 credit hours) – Materials commonly used for biomedical application, such as their properties from a biocompatibility or medical device perspective. In addition, materials interactions with biological systems are examined from the molecular (e.g., protein), cellular, tissue and systemic (whole body) perspective. This is the foundation for the second biomaterials class, which applies these principles toward the application of biomaterials in medical implants, prostheses and devices, along with the regulatory issues associated with biomaterials development.

V. Course Objectives

This course will provide an introduction to the field of biomaterials used in the design of medical devices, and to augment or replace soft and hard tissues. Discussion will include the bulk properties, applications, and in vivo behavior of different classes of natural and synthetic biomaterials. Analysis of the biological response including biocompatibility and hemocompatibility as well as failure processes of implantable biomaterials/devices. Finally, evaluations of relevant case studies covering biomaterial approaches will be conducted.
