# Course Description

This 3-credit course introduces the electrical, optical, magnetic, and thermal properties of materials (in particular solids) and their applications in technologically important devices. Students will be exposed to the following contents: atomic/electronic structure and bonding of materials; fundamentals of quantum mechanics; quantum-mechanical and classical descriptions of materials properties; electrical conduction in metals and semiconductors; dielectric, magnetic and thermal properties of solids; design principles of devices.

## Course Pre-Requisites / Co-Requisites

EMA3011 or equivalent. Basic knowledge of undergraduate-level general physics, chemistry, calculus, and differential equations.

#### Course Objectives

After taking this course, students will be able to

- 1. Describe how the electrical, optical, magnetic and thermal properties of (solid) materials originate from their atomic and electronic structures:
- 2. Understand aforementioned materials properties of different kinds of solid materials;
- 3. Understand how aforementioned materials properties are utilized to design specific electrical, optical and magnetic applications.

## **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
