- A. **Attendance Policy**- Lecture attendance is highly recommended. During certain parts of the class, attendance will be mandatory and a lack of attendance will affect your grade. - C. **Exams**- There will be 4 equally weighted (20%) exams in this course. Exams will be administered during the regular class time, which should avoid exam conflicts. There will be no final exam. Exam dates will be announced.

Make-up exams- Make up exams will be provided only with the prior approval of the instructor in accordance with university policies. (In general, acceptable reasons for excused absence include illness, serious family emergencies, special curricular requirements, military obligation, court-imposed legal obligations, and religious holidays. In all cases, you will be required to provide written documentation, and obtain prior instructor approval. In the case of an emergency that prevents prior notification of an anticipated missed exam, you must notify the instructor as soon as possible. You will not be excused from any exam without following the policy above, with no exceptions. Students not in attendance for the scheduled exam will receive a score of zero. To be clear, Make-up exams will only be allowed in exceptional cases, with prior instructor approval, sufficient documentation, and in accordance of university policies. Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services.
